

ROAD TO STAGECOACH CONTEST RULES

These contest rules are specific to the above contest conducted by Audacy California, LLC d/b/a KSON-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. How to Enter

1. No purchase or payment of any kind is necessary to enter or win the Road to Stagecoach (the “**Contest**”). A purchase or payment will not increase your chance of winning.
